### ROUTES:

**GRANFONDO: 166.8km:** LIVIGNO (Aquagranda), Forcola di Livigno (GPM), junction to Bernina Pass, Bernina Pass (GPM), Pontesina, Samedanm, La Punt, Zernez, junction to Munt la Schera tunnel, Pass dal Fuorn (GPM), Tschier, Santa Maria Val Mustair, Umbrailpass (GPM), Stelvio Military Memorial, junction to Livigno, Isolaccia, Arnoga, Foscagno Pass (GPM), Eira Pass, LIVIGNO (Mottolino).

**SHORT: 106.5km:** LIVIGNO (Aquagranda), Forcola di Livigno (GPM), fork to Bernina Pass, Bernina Pass (GPM), Pontesina, Samedanm, La Punt, Zernez, fork to Munt la Schera tunnel, tunnel exit, Livigno center, Passo di Eira (GPM), LIVIGNO (Mottolino).

### PARTICIPATION

The Granfondo LIVIGNO Alé is open to all FCI card-carrying members who have turned 17 in the calendar year. There are no limits to participation in the M8 category as long as they have a membership card or a competitive medical certificate for the day card.

### CARD-CARRYING MEMBERS OF SPORTS PROMOTION BODIES

All members of Sports Promotion Bodies in possession of sports medical fitness for competitive cycling who have signed the agreement with the F.C.I. for the year 2024 are also eligible to participate except for **ASI** members who must also present the **Bike Card 2025** alongside their card.

### FOREIGN CARDHOLDERS

The event is also open to all foreign cyclists in possession of a UCI license valid for the year 2025, issued by their National Cycling Federation, to be presented compulsorily together with a certificate of competitive sports fitness for cycling (no other disciplines!) in English, as per the model downloadable here [Health Certificate – ENG – Annex E](#) or [Certificat médical – FRA – Annex E](#)

### NON-MEMBERS (italians and foreigners)

The event is also open to **all non-members from Italy and abroad**, for whom a FCI daily card will be activated at a cost of € 10.00 for 'third party liability' insurance coverage during the event. For the issuance of the day card, a certificate of Competitive Fitness (cycling no other disciplines) ex DM 18/2/82 must be presented.

*The event is by invitation only, and the organizing committee may at any time and at its sole discretion decide whether or not to accept the entry or exclude an entrant from the event in case it may damage the image of the event.*

#### **MEDICAL CERTIFICATE**

Participation is subject to regular possession of the following requirement:

- for athletes **registered with the FCI or Sports Promotion Body**: certificate of fitness for competitive cycling (certificates for other types of sports such as triathlon, duathlon, athletics, etc. are not valid);
- for subjects of Italian residence but not registered with the FCI or Sports Promotion Bodies: certificate of fitness to practice sports activity;
- for subjects of foreign residence: certificate of fitness to participate in competitive cycling competitions also issued by a doctor in their country of residence as per the format downloadable here: [Health Certificate - ENG - Annex E](#) or [Certificat médical - FRA - Annex E](#)

***By submitting the online or paper registration form, the foreign competitor declares that he/she has accident insurance and third-party liability insurance.***

***Possession of sports card may be understood as an alternative to verification of possession of regular and adequate certificate only in the case of a sports card bearing the DataHealth logo along with the expiration date of the certificate of fitness for competitive cycling.***

#### **Participation related to professional (contracted elite), elite and under23 athletes**

Professionals, elites (men and women) and under-23s, are only allowed for promotional purposes upon authorization from their sport club to be shown to the Jury will not be allowed to participate in any way in the classification. According to the Implementing Rules approved by Presidential Resolution No. 59 of 31/10/2023 and ratified by the Federal Council on 11/11/2023, athletes who, in 2022 or 2023, have been carded and registered for a UCI team, i.e. WorldTeam (WTT), Women's WorldTeam (WWT), ProTeam (PRT), Continental Team (CTM) and Women's Continental Team (CTW) are not allowed to participate in the event. Athletes with amateur membership, who, in the years 2023 and 2024, have been registered in Elite, Under 23, Women Elite, Women Under 23 categories but do not fall under the previous condition, may participate but are excluded from the category rankings, they will only be able to be included in the overall classification with the indication "cat. ASS"

In Piazza del Comune in Livigno

**Friday, June 27 from 10 a.m. to 8 p.m.**

**REFUND OF THE PARTICIPATION FEE:** In case the registered person does not participate in the event, the fee paid will not be refunded. In case of inability, to be notified STRICTLY by email by midnight on **09/06/2025**, the entire fee may be kept valid for the 2026 entry.

The membership held valid for the following year is nominal and non-transferable to a third party and is valid only for the year following the waiver.

**SUBSTITUTIONS OF ENROLLED ATHLETES:** Substitutions between athletes are permitted only by **09/06/2025**. To make a substitution, you must request the appropriate Form in the Secretariat by writing to: [granfondo@livigno.eu](mailto:granfondo@livigno.eu)

**RIGHTS AND DUTIES:** *The competitor during the course of the event must always respect the control points provided in the route under penalty of exclusion from the final classification. GF Livigno is a Competitive/Competitive event, therefore the strict respect and observance of the rules of the Highway Code applies. Riders overtaken by the "END OF CYCLIC RACE" car will continue the event as COMMON ROAD USERS while still keeping the dorsal on their backs respecting the Highway Code. It is obligatory to wear the handlebar number clearly visible and not rolled to the frame and the dorsal number provided by the organization. These numbers may not be changed in format. Use the approved hard helmet and fastened for the duration of the race. In order to protect the environment, it is absolutely forbidden for participants to throw garbage of any kind along the roads, it is obligatory to place it only in the special containers placed near the refreshment points and/or at the finish line. Anyone caught by the staff of the organization and / or the race marshals to the non-compliance with this rule, will be SANCTIONED UNTIL DISQUALIFICATION.*

**TIMING:** Official Timer Evodata . Each participant must have a valid personal chip or a daily rental chip that can be purchased/rented directly at the secretary's office after picking up the race packet. **AWARDS:** Awards will be given at the M'Eating Point Refuge in Mottolino (In the finish area, where the "Pizzoccherata" by the Pizzocchero Academy will also take place)

- from 13.00 absolute winners
- to follow the categories

**AWARD WINNERS:**

Prizes will be awarded to:

- the first three (3) overall Short/Grand Fondo finishers
- the first three (3) women classified absolute Short/Gran Fondo
- for both courses the first place in the men's Elite/sport 19/29, Master 1 30/34, Master 2 35/39, Master 3 40/44, Master 4 45/49, Master 5 50/54, Master 6 55/59, Master 7 60/64 and Master 8 65 and over
- for both routes the first woman placed in the categories Sport Elite Women 19/29, Master Women 1 30/39, Master Women 2 40/49, Master Women 3 50 and over.

The organizers reserve the right, as provided by the implementing regulations, to merge categories based on the number of participants, specifically: Sport Elite Woman 19–29, MW1 30–39, MW2 40–49, and MW3 50 and over.

The special 'Pogacar Segment' prize will be awarded to the athlete who records the fastest time between Passo d'Eira and the finish line.

Any other prizes will be announced at the start.

**Prizes not collected will NOT be sent home.**

**TEAM CLASSIFICATION:** Team classification is not provided.

**RIGID HELMET:** Mandatory.

**MEDICAL ASSISTANCE:** Ambulances, accompanying medical cars and moto-medics, doctors and qualified paramedical personnel.

**MECHANICAL ASSISTANCE:** Cars and motorcycles in tow and service points along the route.

**PRIVATE ASSISTANCE:** Any private assistance following the race is prohibited, under penalty of disqualification from the race and the runner(s) being assisted. However, flying refueling is allowed at points provided by the organization (see refreshment points).

**RADIO ASSISTANCE:** along the route and at the finish line.

**REFUGE POINTS:** at

- km 70 in the village of Zernezz
- km 119 Umbrailpass.

**SHOWERS SERVICE:**

At Aquagranda by presenting the bib number.

**CANCELLATION OF THE EVENT:** If, due to force majeure, the event does not take place, the registration fee will not be refunded

**MANDATORY EQUIPMENT OF THE CYCLER:** Cyclists, who participate in a Cross-Country event, must compulsorily have the following equipment with them at the time of the start check: - a set of tools for tire/tubular disassembly; a spare inner tube (or tubular); - a pump (or canister) for inflating the wheels; - a water bottle. In addition, all participants, throughout the duration of the race, must compulsorily wear an approved hard helmet and keep both the hard race number in the frame and the back number on the jersey attached, legibly.

**BROOM WAGON SERVICE:** For any withdrawals

**COMPLAINTS:** Any complaints must be received by the Jury within the regulation deadlines accompanied by the fee provided by the F.C.I.

**JURISDICTION**

For disputes arising from the application and interpretation of these regulations the Court of Brescia is elected as competent.

Mendacious self-certification will be prosecuted according to law.

**CASES OF CANCELLATION OR SUSPENSION OF THE EVENT:**

1. The cases of impossibility of holding the event that result in its cancellation are cases determined by force

majeure, fortuitous event, or any other kind not attributable to the organization, such as:

- Atmospheric events such as, but not limited to, snow, hail, cloudbursts, ice formation on the road or other weather conditions that make the holding impracticable;
- Disastrous events such as, but not limited to, earthquakes, floods, major fires, natural or manmade disasters;
- Nefarious event to the detriment of one or more participants;
- Measure or provision of the Public Authority, or of cycling promotion bodies or sports federations;
- Any other cause or event, not attributable to the Organizer, that makes it necessary to cancel the event.

2. Any cause or event not attributable to the Organizer shall be considered to be any fact or event, of natural origin, or determined by man, which does not depend on the Organizer's willful misconduct or negligence or, in any case, to the occurrence of which the Organizer has not wilfully or culpably contributed.

3. The cancellation of the event shall be communicated by the Organizer by email whose address was made known at the time of registration, or even only through social channels, as soon as possible, so as to allow the participants timely knowledge and to avoid any inconvenience as much as possible

4. Where this is possible and in the absence of hazardous conditions, the Organizer will arrange for the postponement of the event to another date, giving timely notice to those registered.

5. However, this is without prejudice to the Organizer's right, where concrete conditions permit, to allow the event to take place by changing the planned route, in order to avert dangerous situations for runners.

6. In case of impossibility of holding the event, for the reasons mentioned in the previous paragraphs, no amount will be due in restitution to the registered participants.

#### **RULES:**

*It is the obligation of all participants in the Granfondo to strictly respect and observe the rules of the Highway Code, committing the utmost prudence and diligence in view of the dangers underlying the use of bicycles. For everything not indicated in these Regulations, the rules established in the F.C.I. regulations apply. Participants are required to comply with all anti Covid health indications and restrictions in force at the time of the event or provided by the organizing committee. The Organizing Committee and the Organization disclaim all liability for accidents or damage to persons, animals and property, including bicycles, of any kind or nature whatsoever that may occur before, during and after the Granfondo cycling event (i.e. by way of example, but not limited to, resulting from unfavorable weather conditions, uneven or impervious road surface, insufficient lighting). Also for this purpose, the participant who does not already have his or her own accident policy is strongly advised to activate one. By registering for the Granfondo, the participant expressly accepts all the provisions set forth in these regulations and agrees to indemnify and hold harmless the Organizing Committee and, in general, the Organization, from all liability and any claims and/or demands for damages to persons and/or property that may result from accidents of any kind and nature that may occur before, during and after the Granfondo*

*In the event that the Organizing Committee or the Organization should be unsuccessful as a result of third-party claims and/or demands for compensation for damages to persons and/or property resulting from the matters indicated in this article, the member agrees to indemnify the Organizing Committee and the Organization. The entrant also undertakes to indemnify the Organizing Committee and the Organization in the event of damage to the image and reputation of the overall event, the Organizing Committee and the Organization, resulting from the entrant's own behavior not in accordance with the rules of these regulations and the spirit of the event.*

### **SIGNATURE AND AUTHORIZATION OF PERSONAL DATA**

*By submitting the registration form online or by email by signing the appropriate form, the competitor or, in the case of a minor, the parent acting on his or her behalf, expressly declares, under his or her own responsibility, that he or she is in possession of a medical certificate in accordance with the Ministerial Decree of 18.02.1982, third party liability insurance and that he or she has read these regulations, accepting them unconditionally in every point and expresses consent to the use of his or her personal data in accordance with Legislative Decree No. 196/2003. By use/processing of personal data is meant any operation or set of operations concerning the collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination, distribution of data, even if not registered in a database in accordance with art. 7 of Legislative Decree n.196/2003. Each member has the right to exercise access to personal data, as well as to obtain information about his or her data; to request their deletion, blocking, updating, rectification, integration, and to oppose the processing of his or her data, addressing Asd Cycling Brixia Team, with headquarters in via Piave 46, Castrezzato (BS), as the data controller. By submitting the registration form online or via email by signing the appropriate form, the participant also expresses his or her consent, so that any photos, videos, audio - and/or video recordings, of any kind and type, that portray/reproduce him or her, produced during the event, may be freely stored, reproduced, published and marketed by the Organizing Committee, the Organization and sponsors, without the right to any relative compensation and/or indemnity. In particular, the participant expressly authorizes the Organizing Committee, the Organization and the sponsors, together with the relevant media partners, to use any still or moving images that may depict him/her during his/her participation in the Race, in all media, including promotional and/or advertising materials. The participant agrees that such data and related material may be made available to professional photographers and/or photostudios specifically commissioned by the organization for the purpose of conducting photo reports on the Race.*
